#### **CEBA**

CEBA- refers to the Canada Emergency This program is Business Account. being offered by the Government of Canada. Businesses can apply for this program website on our www.brunocu.com. **This** program became available in May of 2020 and has now been extended to March 31, 2021. Under this program, businesses must have a business account with a financial institution. The program has now been expanded so that the company is now able to apply for \$60,000 of which if \$40,000 is paid in full by Dec 31, 2022, \$20,000 will be forgiven. If not, the loan will then bear interest at 5% until Dec 31. 2025, when the total loan will become due. There is no interest that will be due annually.

#### **MEMBER CARD DEBIT CARDS**

Any Bruno Credit Union Member Card issued after November 23, 2020, will have the updated tap feature limits of \$250 per transaction and a cumulative limit of \$400.00. If you have a card issued prior to this date, the higher tap limits will only be available after you have used it consecutively 3 times at a merchant where you insert your card and use your PIN. It can be used on 3 different dates, at 3 different merchants but must have no tap purchases in between the PIN transactions. The increase in tap limits is being implemented because of COVID and people and merchants prefer to use contactless methods of payment.
